AFTER CARE INSTRUCTIONS-Brows

HAIR STROKE BROWS Blot away seeping the first couple of days as needed. For 3 days, at bedtime wash with sterile, distilled or boiled water only and VERY GENTLY clean the surface area without rubbing. On the fourth day, M T W T F S S morning and night, apply a thin coat of the provided oil, serum or ointment to keep slightly moist until completely healed.

POWDER BROWS Blot away seeping the first couple of days as needed. Gently wash for 3 days, DO NOT allow the water to flow to come into direct contact, pat dry and apply a thin coat of ointment at least twice daily to keep moist until completely healed.

- DO NOT use antibacterial / antibiotic ointments or products with fragrances or harsh chemicals, Peroxide, Retin A or Glycolic Acids for 4 weeks following procedure.
- NO direct water spray, cleansers, creams, make-up or any other products on procedure area for 10 days.
- UNDER NO CIRCUMSTANCES should you scrub, scratch, or pick treated areas.
- AVOID Sun exposure and tanning beds, facials, sweating, swimming, whirlpools, and exertion for at least 14 days.
- KEEP SMALL CHILDREN AND PETS away from treated areas until completely healed.
- FOLLOW ALL post care instructions provided.

Brow Healing Schedule

Days 1 & 2: The eyebrows are approximately 20 to 25% darker and bolder in width than they will be when healed. Your skin is red under the pigment, which causes the color of the pigment to appear darker. There is some swelling, although difficult to actually see due to the thickness of the skin in the eyebrow area. This will subside. Exfoliation, which begins in a few days, will cause excess pigment surrounding the eyebrow procedure to flake away and a more narrow appearance will result. New skin will heal over the pigmented area and result in a softer appearance of your eyebrows. Don't be concerned that your eyebrows initially appear darker and heavier in size than you desire. This is all part of the process.

Day 3: Eyebrows start to itch and will appear a bit thicker in texture. Exfoliation begins.

Day 4: The skin begins to flake, peeling from the outside edges first.

Day 5: Color finishes flaking off and appears softer and grayer for a few days until color clarifies.

Days 7-10: Color may appear to disappear during the healing process.

Day 11-21: Through the final healing stages, color will emerge and refine.

NOTE: Be prepared for the color intensity of your procedure to be significantly sharper, brighter, or darker than what is expected for the final outcome. It will take time for this transition, based on how quickly the outer layer of your skin exfoliates. Brows can fade 10-50%. Since skin is delicate and sensitive areas may swell slightly or redden for 1-3 days. Permanent makeup procedures are affected by the canvas (your skin) that they are performed on. If your skin is sun damaged (even from tanning beds), thick and uneven in texture, and/ or excessively dry or oily, the result cannot be expected to be perfect after the initial procedure. Lifestyle, medications, smoking, metabolism, facial surgery, and age of skin, all contribute to fading. Color refreshers are sometimes needed to ensure the best results and to keep your permanent makeup looking the best.

FOLLOW UP PROCEDURES

Follow up procedures are for any shape or color modifications needed. As well as replace any area or section that did not heal in properly.

FOLLOW UP APPOINTMENTS AND CHARGES

One follow up procedure is offered between six (6) to eight (8) weeks of the initial permanent make-up application. It is the clients' responsibility to schedule follow up procedures. Whether \$75 or a qualified free procedure, the opportunity for a follow up procedure will be forfeited after eight (8) weeks.

FOLLOW UP CANCELLATION / RESCHEDULING AND NO SHOWS:

48 hour cancellation/rescheduling notice is required. Should you not provide 48 hours' notice or no show, you will forfeit the prepaid fee/deposit for the wasted appointment time and the \$75 follow up rate will no longer apply.
